seL4 International Association Membership Agreement

This Membership Agreement (the "Agreement") is entered into by and between seL4 International Association, a Swiss association (Verein) ("the seL4 Association") and the person or entity listed below in the signature page of this Agreement (the "Member"). This Agreement will be effective as of the date signed by the last party below (the "Effective Date").

This document is available for e-signing through the sign-up process on https://sel4.systems. A countersigned copy will be returned to you by email for your records when your eligibility for membership has been confirmed and an invoice will be emailed to you for payment of applicable membership fees. Note that this is not an indication of interest; execution of this Agreement creates an irrevocable, binding obligation for the member company to make the payments provided for and to otherwise perform in accordance with its terms.

The governance for the seL4 Association will operate pursuant to the Articles of Association (the "Articles"), with the then current version available on the seL4 Association's website, and as amended in the future by the seL4 Association's Members.

Members will enjoy the privileges and undertake the obligations described in the Articles and will comply with all policies as the seL4 Association's Board may from time to time adopt with notice to Members.

Premium Membership Term:

Premium membership requires an initial two-year membership commitment. One year's fees are due on acceptance as a member, and the second year's fees are due at the first anniversary of membership. At the second anniversary of membership, if membership is not canceled at least thirty days prior to the second anniversary of membership, a prorated amount of the applicable fees for the remainder of that calendar year (a "stub period") will be invoiced (and membership will proceed on a calendar-year based renewal cycle thereafter).

General Membership Term and Fee Scale:

In calculating the appropriate annual fee for General membership, please indicate your current consolidated employee headcount in the membership level selected. Solely for purposes of calculating fees, Consolidated Employees include all employees of Related Companies (as defined in the Articles), which include any direct and indirect parent companies, and all sister and subsidiary entities. Employees do not include third party contractors. For General Members, at the first anniversary of membership, if membership is not canceled at least thirty days prior to the first anniversary of membership, a prorated amount of fees for the remainder of that calendar year will be invoiced (and membership will proceed on a calendar-year based renewal cycle thereafter).

Membership Terms:

For all levels of membership, an initial full year's payment of fees is due upon receipt and acceptance of an executed membership agreement and payable within thirty days of the date of invoice from the seL4 Association. Agreements signed before the 15th of the month will be invoiced as if active on the first of the month of signature. Agreements signed on or after the 15th will be invoiced as if active on the 1st of the following month. All fee amounts are irrevocable and non-refundable commitments based in Swiss Francs (CHF). In no event will fees be refunded, upon a Member's resignation or otherwise.

Each Member acknowledges that the seL4 Association depends upon reliable membership renewal information to budget effectively, and that the seL4 Association's ability to provide the services set forth in its mission would suffer in the event of nonpayment of membership fees. Each Member acknowledges seL4 Association's Good Standing Policy, available on the seL4 Association's website.

Notice of any increase in membership fees for the following calendar year will be given on or before October 15 in the current calendar year. Member's membership for each calendar year and any stub period, and its obligation to pay membership fees for the following calendar year or stub period, as applicable, will renew annually for successive one-year terms, unless the applicant delivers written notice of non-renewal to the seL4 Association on or before December 1 of the current membership year.
